#### **BID OPENINGS**

2019 Lower White River Pest Control District Commercial Equipped Applicator Bid.

Chairman Rector read the 2 bids received. Rocky Mountain Weed Management bid \$107/hour for one applicator, a 4x4 truck and a 4 wheeler if needed. Herbicide at actual cost plus 10%. Elder Weed Spraying, Inc. bid \$85/hour with a truck or UTV. Bare ground chemical is \$150/acre. Noxious weeds depends on chemical. They listed chemical prices per guart or ounce.

# 2019 Lower White River Pest Control District Aerial Spray Bid

Commissioner Rector read the 1 bid received. Coulter Aviation bid for control of flies and mosquitoes with Malathion is \$5.93/acre including chemical and application. Price for application only of Malathion is \$1.85/acre. They bid \$2.77/acre spraying Permex 30-30 with Cal Par ULV oil as a carrier. Application only of Permex 30-30 with Cal Par ULV oil is \$1.85/acre.
