

RESOLUTION NO. 2021 - 24

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, CORRECTING DUPLICATE RESOLUTION NO. 2021-21, PASSED ON SEPTEMBER 28, 2021, CHANGING IT TO RESOLUTION NO 2021-22

WHEREAS, the Board of County Commissioners of Rio Blanco County, Colorado, passed Resolution 2021-21 on August 10, 2021, titled: A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, APPROVING G & E MOYER MINOR SUBDIVISION PSUB-0002-21 IN RIO BLANCO COUNTY, COLORADO; and

WHEREAS, by clerical error, the Board of County Commissioners passed a duplicate Resolution 2021-21, on September 28, 2021 titled: A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, OPPOSING VACCINATION AS A CONDITION OF EMPLOYMENT FOR COUNTY EMPLOYEES AND TO NOT USE ITS LIMITED RESOURCES TO ENFORCE VACCINE OR MASK MANDATES; and

WHEREAS, the Resolution passed on September 28, 2021 will now and forever be corrected and known as RESOLUTION 2021-22, A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, OPPOSING VACCINATION AS A CONDITION OF EMPLOYMENT FOR COUNTY EMPLOYEES AND TO NOT USE ITS LIMITED RESOURCES TO ENFORCE VACCINE OR MASK MANDATES.
