

RESOLUTION NO. 2013 - 08

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF RIO BLANCO COUNTY, COLORADO, RESCINDING RESOLUTION 2013-5**

WHEREAS, on January 28, 2013 the Board of County Commissioners of Rio Blanco County, Colorado, adopted Resolution 2013-5 amending the official County Road Map by the addition of County Road 108, also known as Cedar Ridge Road; and

WHEREAS, public notice of a public hearing to consider the Resolution was published in the newspaper of general circulation in Rio Blanco County on January 17, 2013, and January 24, 2013, notifying the public that the public hearing would be held on February 19, 2013 at 11:15 am.; and

WHEREAS, the Resolution was mistakenly considered and adopted as Resolution No. 2013-5 at the January 28, 2013 meeting;

**NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF RIO
BLANCO COUNTY, COLORADO FINDS AS FOLLOWS:**

- A. The public hearing to consider the amendment of the County Road Map by the addition of County Road 108 will be held after proper notice, on February 19, 2013 at 11:15 a.m. in Rangely at the County Annex;
- B. The Resolution 2013-5 adopted on January 28, 2013 should be rescinded.


**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY

The Board of County Commissioners of Rio Blanco County, Colorado declares that it would have adopted this Resolution and each section, subsection, sentence, clause, phrase, or portion herein, despite the fact that any one or more sections, subsections, sentences, clauses, phrases, or portions would be declared invalid or unconstitutional.






