**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, CANCELLING CERTAIN COUNTY HELD TAX LIEN CERTIFICATES ON SEVERED MINERAL INTEREST PROPERTIES**

**WHEREAS**, certain severed mineral interest properties are assessed to various taxpayers as listed on attached Exhibit A; and

**WHEREAS**, the severed mineral interest properties assessed on various account numbers listed on Exhibit A are delinquent; and

**WHEREAS**, the tax lien sale certificates listed on attached Exhibit A for the years stated are held by the Board of County Commissioners of Rio Blanco County, Colorado and are deemed uncollectible; and

**WHEREAS**, the Rio Blanco County Treasurer believes that by cancelling the listed tax lien sale certificates held by the Board of County Commissioners of Rio Blanco County, Colorado and keeping the current taxes active, these accounts may be sold to investors in the current year's tax sale;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Rio Blanco County, Colorado as follows:

1. The tax lien sale certificates listed on attached Exhibit A are hereby cancelled.
2. The Treasurer of Rio Blanco County is hereby authorized and directed to cancel said tax lien certificates.


