**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO
BLANCO COUNTY, COLORADO, CANCELING CERTAIN UNCOLLECTIBLE
DELINQUENT POSSESSORY INTEREST PROPERTY TAX ACCOUNTS FOR THE TAX
YEAR 2009**

WHEREAS, the Rio Blanco County Treasurer has requested the Board of County Commissioners of Rio Blanco County, Colorado cancel certain uncollectible delinquent possessory interest property taxes for the year 2009; and

WHEREAS, the possessory interest property tax accounts listed on Exhibit A attached hereto and incorporated herein by this reference for the tax year 2009 remain unpaid and uncollectible;


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Rio Blanco County, Colorado as follows:

2. The Treasurer of Rio Blanco County is hereby authorized and directed to cancel said uncollectible delinquent possessory interest property taxes, including accrued interest and fees, if any, for the tax year 2009 for the accounts listed on the attached Exhibit A.

If any section, subsection, sentence, clause, phrase or portion of this Resolution is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution. The Board of County Commissioners of Rio Blanco County, Colorado, declares that it would have adopted this Resolution and each section, subsection, sentence, clause, phrase, or portion herein, despite the fact that any one or more sections, subsections, sentences, clauses, phrases, or portions would be declared invalid or unconstitutional.
