

**RESOLUTION NO. 2014-09**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, APPROVING APPOINTMENTS OF MEMBERS TO THE NORTHWEST REGIONAL WORKFORCE DEVELOPMENT BOARD.**

WHEREAS, Grand, Jackson, Moffat, Rio Blanco and Routt Counties have previously agreed to be the Northwest Workforce Development Region for local service delivery, planning and administrative purposes of the One-Stop system; and

WHEREAS, the counties identified above have previously established the Northwest Workforce Development Board; and

WHEREAS, it is necessary for the counties to annually appoint members and Local Elected Officials to the Northwest Workforce Development Board to ensure that the responsibilities outlined in the Northwest Workforce Development Plan are carried out; to appoint a Chief Elected Official for the Region, and to identify a provider of One-Stop Services.

NOW THEREFORE, be it resolved that:

1. The following named individuals are hereby appointed to serve on the Northwest Workforce Development Board for 2014, in addition to any other members who may need to be appointed by the Board itself during 2014.

The Board of County Commissioners of Rio Blanco County, Colorado declares that it would have adopted this Resolution despite the fact that any one or more sections, subsections, sentences, clauses, phrases, or portions would be declared invalid or unconstitutional.
