

RESOLUTION NO. 2014 - 26

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, CANCELLING CERTAIN COUNTY HELD TAX LIEN CERTIFICATES ON SEVERED MINERAL INTEREST PROPERTIES

WHEREAS, certain severed mineral interest properties are assessed to various taxpayers as listed on attached Exhibit A; and

WHEREAS, the severed mineral interest properties assessed on various account numbers listed on Exhibit A are delinquent; and

WHEREAS, the tax lien sale certificates listed on attached Exhibit A for the years stated are held by the Board of County Commissioners of Rio Blanco County, Colorado and are deemed uncollectible; and

WHEREAS, the Rio Blanco County Treasurer believes that by cancelling the listed tax lien sale certificates held by the Board of County Commissioners of Rio Blanco County, Colorado and keeping the current taxes active, these accounts may be sold to investors in the current year's tax sale;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Rio Blanco County, Colorado as follows:

1. That the said taxes, penalties and costs due, along with the Tax Lien Sale Certificates, as listed on Exhibit A, are hereby cancelled.
2. The Treasurer of Rio Blanco County is hereby authorized and directed to cancel said taxes, penalties, interest, and costs, and Tax Lien Sale Certificates, as listed on Exhibit A, pursuant to Section 39-10-114(2)(a) C.R.S.
