

RESOLUTION NO. 2014-30

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, AUTHORIZING THE ESTABLISHMENT OF A CREDIT CARD ACCOUNT AT CREDIT UNION OF COLORADO FEDERAL CREDIT UNION


WHEREAS, the Board of County Commissioners of Rio Blanco County, Colorado (Board) wishes to authorize the establishment of a credit card account at the Credit Union of Colorado Federal Credit Union (Credit Union) providing for certain elected officials and employees of Rio Blanco County to utilize credit cards issued by the Credit Union;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO AS FOLLOWS:


1. The Board hereby authorizes the opening of a credit account at the Credit Union of Colorado Federal Credit Union.
2. The individuals listed on Exhibit A, attached hereto are authorized and permitted to transact business on this account.
3. The Credit Union is authorized to issue credit cards to the named individuals listed on Exhibit A with credit limits as stated on Exhibit A, effective January 1, 2015.
4. In the event of termination, resignation or addition of any individual(s) listed on Exhibit A, a Change of Authorized User Notice form will be provided to the Credit Union.
5. The Board is authorized to transact business on this account, including authorization of credit cards to be issued, canceling credit cards, establishing credit limits, and requesting credit limits to be increased.


