

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS  
OF RIO BLANCO COUNTY, COLORADO, ESTABLISHING THE DISTRIBUTION OF TITLE I FEDERAL  
FOREST RESERVE FUND MONEY**

**WHEREAS**, on February 17, 2015, Rio Blanco County, Colorado, received \$254,539.60 of Title I Federal Forest Reserve Fund Money for Federal Fiscal Year 2014 based on the 25% payment methodology under the Twenty-Five Percent Fund Act of 1908, and

**WHEREAS**, Rio Blanco County was notified by the Colorado Department of Local Affairs that the payment it received included an overpayment of \$15,093.21 based on the full payment methodology under the subsequently reauthorized (for two years) Secure Rural Schools and Self Determination Act but the overpayment will not have to be refunded as it will be deducted from the payment due to the County for Federal Fiscal Year 2015, and

**WHEREAS**, 30-29-101 Colorado Revised Statute, was amended on May 11, 2009, to require that the discretionary portion of Title I Federal Forest Reserve Fund Money be distributed based upon an agreement between Rio Blanco County and School Districts located within the County; and

**WHEREAS**, on July 17, 2015, an agreement was reached between Rio Blanco County and the School Districts which determined the distribution of the discretionary portion of Title I funds.

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO:**

- 1) The Title I Federal Forest Reserve Fund Money discretionary funds received on February 17, 2015, in the amount of \$239,446.39, shall be distributed as follows: Rio Blanco County Road & Bridge-- \$99,769.33, RE-1 School District-- \$79,699.68, RE-4 School District-- \$59,596.69 and RE-3-JT School District-- \$380.69.
- 2) The overpayment received on February 17, 2015, in the amount of \$15,093.21, shall be carried as unearned revenue in the Rio Blanco County Road & Bridge Fund, and deducted from the County's share of the Title I Federal Forest Reserve Fund Money for Federal Fiscal Year 2015.
- 3) A certified copy of this Resolution shall be delivered to the County Treasurer of Rio Blanco County, Colorado.
- 4) Upon receiving the certified copy of this Resolution, the County Treasurer shall distribute the Title I Federal Reserve Fund Money as described in this Resolution.
