A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, CANCELLING TAXES, INTEREST, PENALTIES AND COSTS REGARDING ACCOUNT NUMBER M7500122.
