A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RIO BLANCO COUNTY, COLORADO, CANCELING CERTAIN UNCOLLECTIBLE DELINQUENT PERSONAL PROPERTY TAXES, PENALTIES, INTEREST AND COSTS PURSUANT TO SECTION 39-10-114(2)(a) C.R.S.

WHEREAS, the Treasurer of Rio Blanco County has requested the Board of County Commissioners of Rio Blanco County, Colorado to cancel certain uncollectible delinquent personal property taxes for tax year 2012 and tax year 2013; and
